In line with the Department of Education's (DepEd) commitment to continuously strengthen and enhance the Philippine basic education system, the Learning Systems (LS) Strand, in collaboration with the Operations Strand, shall spearhead a comprehensive review of the Department's existing curriculum, as well as its co-curricular and extra-curricular programs. This initiative forms part of DepEd's broader efforts to ensure that all programs remain responsive, evidence-based, and aligned with the developmental needs of Filipino learners.

A key component of this undertaking is the administration of the Physical Education, Sports, and Health Survey from **March 25 to 31, 2026**, which aims to identify gaps, document best practices, and determine areas requiring harmonization, policy refinement, program enhancement, and overall systems improvement.
