2. 4. To ensure that there will be no disturbance of classes, the School Head shall guarantee the following:
 - a. All learner participants shall be excused from their respective classes/examination and will be given a special exam on a later date and;
 - b. An alternate Teacher will take over the class of Teacher participant with the Instructional Plans prepared by them.

6. Travel and other allowable expenses of the participants will be charged in their respective School MOOE, local funds or any available funds subject to the usual accounting and auditing rules and regulations.




