SUBJECT: **WORKSHOP ON THE DEVELOPMENT OF CONTEXTUALIZED PSYCHOSOCIAL SUPPORT SERVICES AND RESPONSE INTERVENTIONS FOR THE PROMOTION OF SAFE, INCLUSIVE, AND CONFLICT-SENSITIVE LEARNING ENVIRONMENTS**



1. This office through the School Governance and Operations Division - Youth Formation Unit, the Disaster Risk Reduction and Management Service and the Division Mental Health and Psychosocial Support Response Team, shall jointly implement Project BRAVE (**B**uilding **R**esilience and **A**dvocacy for **V**iolence-Free and **E**mpowered Learners).
2. In line with this initiative, a Workshop on the **Development of Contextualized Psychosocial Support Services and Response Interventions for the Promotion of Safe, Inclusive, and Conflict-Sensitive Learning Environments** will be conducted on **May 11–15, 2026** (inclusive of travel days) at **Baguio Teachers' Camp, Baguio City**. The workshop aims to develop, pilot-test, standardize, and institutionalize a Division-wide Audience/Client-Appropriate Psychosocial Support Services (PSS) Manual that ensures consistent, contextualized, and evidence-based delivery of mental health and psychosocial support interventions across all schools and offices.
3. The expected participants, refer to the attached annex, are required to bring their own laptops and extension cords.
4. Expenses for meals, snacks, accommodation, and other training-related costs shall be charged against the **DPRP Downloaded Funds and PSEF**. Meanwhile, transportation, per diem, and incidental expenses of participants and TWG/PMT members shall be charged against the local funds/MOOE of the school, subject to the usual auditing and accounting rules and regulations.
