**SUBMISSION OF REPORTS ON DELIVERED TEXTBOOKS AND OTHER
LEARNING RESOURCES WITH ISSUES OR DEFECTS**

All others concerned

1. In line with ensuring the quality, integrity, and accountability of delivered and ongoing deliveries of centrally procured textbooks and other Learning Resources (LRs), the Schools Division of Nueva Vizcaya, through the Curriculum Implementation Division – Learning Resources Management Section (CID-LRMS), hereby directs the submission of reports on delivered textbooks and other learning resources with identified issues or defects under the Error Watch Initiative.

2. All districts are hereby directed to submit reports on identified errors, issues, or defects in delivered Learning Resources using the online Error Watch Report Template, which already serves as a district-level consolidation tool and requires information on, but not limited to the following:

- Title and type of Learning Resource delivered
- Delivery date
- Specific issue or defect identified
- Quantity of affected Learning Resources
- Name of printer or publisher
- School and district concerned

3. District Learning Resource (LR) Coordinators shall facilitate the gathering, consolidation, and validation of data from schools within their respective districts and ensure that accurate and complete information is reflected in the online template.

4. Public Schools District Supervisors (PSDS) shall monitor district compliance and support the District LR Coordinators in ensuring the timely and accurate submission of reports.

The Learning Area Supervisors shall be responsible for reviewing and validating reported errors and for informing, coordinating with, and guiding the field offices and schools regarding the identified errors, issues, or defects in the Learning Resources (LRs) within their respective learning areas. They shall ensure that verified information is properly disseminated to the field and aligned with curriculum standards.
6. The Error Watch Report shall be accomplished and submitted online through the official link: <https://tinyurl.com/8k29wvyv>. Learning Resource (LR) Coordinators are hereby directed to encode and update the required data in the prescribed template at the end of every week, starting on Friday, April 24, in view of the presence of learning resources that remain undelivered and are still subject to monitoring.
