1. This Office, through the School Governance and Operations Division – Disaster Risk Reduction and Management Service (SGOD-DRRMS), in partnership with the DepEd Regional Office II, pursuant to Regional Memorandum No. 199, s. 2026, will host the **Training of Trainers on the M7X Ready Program and PlanSmart for Safe Schools (PSSS) Application** on **May 20–23, 2026** at the **Baguio Teachers' Camp, Baguio City**.
2. The program shall start at **exactly 8:00 AM on May 20, 2026**. Participants' check-in time is set at 2:00 PM on the same date.
3. The identified participants of SDO Nueva Vizcaya, as listed in the attached document, are expected to conduct a **division-wide roll-out** of the training to all public schools in the division.
4. The registration fee, which covers board and lodging for the duration of the activity, shall be charged against the downloaded **Disaster Preparedness Related PPAs (DPRP) funds**. Meanwhile, transportation expenses, per diem, and incidental expenses of participants shall be charged against the MOOE or other local funds, subject to existing accounting and auditing rules and regulations.
