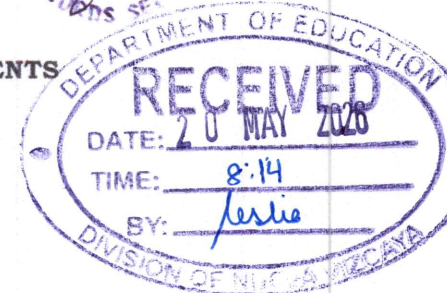

2. **DepEd Order No. 005, s. 2024**, titled "Rationalization of Teachers' Workload in Public Schools and Payment of Teaching Overload", and
