**Invitation to Bid**

- 1) The *Department of Education, Schools Division of Nueva Vizcaya*, through the FY 2026 General Appropriations Act Sub Allotment Release Order No. OSEC -2-26-01197 intends to apply the sum of **One Million Nine Hundred Ninety Two Thousand Eight Hundred Sixty Pesos (Php 1,992,860.00)**, being the Approved Budget for the Contract (ABC) to payments under the contract for the **Construction and On-site Installation of Learning Continuity Spaces (LCS) Lot 17**;

\*Note: For Type 1 (elevated), for Type 2 (slab on grade)

Bids received in excess of the ABC for each *lot* shall be automatically rejected at bid opening.

- 2) The *Department of Education, Schools Division of Nueva Vizcaya* now invites bids for the above mentioned project<sup>3</sup> Completion of the Works is required within **30 Calendar Days**. Bidders should have completed within **10 years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in **Error! Not a valid bookmark self-reference.** (ITB).
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the IRR, otherwise known as the “New Government Procurement Act (NGPA)”.
- Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4) Interested bidders may obtain further information from the *Department of Education, Schools Division of Nueva Vizcaya*, and inspect the Bidding Documents at the address given below from **8:00 AM-5:00 PM, during office hours**.

<sup>3</sup> A brief description of the scope of Works should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

- 5) A complete set of Bidding Documents may be acquired by interested bidders on **June 4-22, 2026**, from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php 5,000.00 for each lot**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6) The *Department of Education, Schools Division of Nueva Vizcaya* will hold a **Pre-Bid Conference on June 10, 2026, 9:00 AM** at Conference Hall of SDO- Nueva Vizcaya, which shall be open to prospective bidders.
- 7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the address indicated below **on or before 9:00 AM on June 22, 2026**. Late bids shall not be accepted.
- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
- 9) Bid opening shall be at **9:30 AM on June 22, 2026 at the Conference Hall of SDO- Nueva Vizcaya**. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
- 10) The award of contract shall be based on the **Lowest Calculated Responsive Bid (LCRB)** pursuant to Section 58 of the NGPA.
- 11) The *Department of Education, Schools Division of Nueva Vizcaya* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without thereby incurring any liability to the affected bidder or bidders.
