The School Governance and Operations Division (SGOD), through the School Health and Nutrition Unit (SHNU), requires all **Public and Private** Elementary and Secondary Schools to submit the **Baseline Nutritional Status Report for School Year 2026–2027** in accordance with DepEd Memorandum No. 165, s. 2010, reiterating the conduct of Nutritional Assessment for all learners from Kindergarten to Grade 12 using the **Body Mass Index (BMI)** and **Height-for-Age (HFA)** indicators.

The submitted data shall serve as the **Baseline Nutritional Status Report for SY 2026–2027** and shall be utilized as basis for the implementation of School-Based Feeding Programs (SBFP), nutritional interventions, and other health and nutrition-related programs and activities for the incoming school year.

All schools and districts are required to submit both **soft and hard copies** of the consolidated nutritional status report, including complete attachments of results per grade/year level, to the School Health and Nutrition Unit on or before **June 23, 2026**. Soft copies shall likewise be uploaded through the links provided.
