The Plastic Bank Schools Program empowers schools to properly collect, segregate, and recover plastic waste through a structured system with incentives.

It connects schools, local governments, and junkshops to turn plastic waste into measurable environmental and social impact by diverting plastics and other school recyclables away from landfills and into junkshops, while also expanding junkshops' network of school-based suppliers.

WHY IT MATTERS FOR YOUR CITY



Schools and households are sources of plastic waste and many communities lack consistent systems for segregation and recovery. This program provides a ready-to-deploy model with tracking and incentives.

This leads to cleaner and more engaged students and communities and improved waste diversion.

1 SCHOOLS REGISTRATION

Schools download and register in the app and complete program orientation and training



2 COLLECTION & SEGREGATION

Schools implement proper waste segregation and prepare stored plastics and other recyclables for selling



3 SELLING & APP RECORDING

- Partner junkshops buy the recyclables and records the transaction through the app
- Plastic Bank verifies the collection



4 INCENTIVES & RECOGNITION

Schools receive rewards based on collection performance
Top-performing schools and junkshops are recognized monthly
