**CONDUCT OF PROJECT BEST (Bringing Out Everyone's Skills and Talents) IN
CELEBRATION OF THE 48TH NATIONAL DISABILITY RIGHTS WEEK (NDRW)**

1. As part of the celebration of the 48th National Disability Rights Week (NDRW) with the theme, "Rights First, Legislation Forward – Strategic Action for Equal Participation and Inclusive Development," the Schools Division Office of Nueva Vizcaya, through the Curriculum Implementation Division (CID), shall conduct Project BEST (Bringing Out Everyone's Skills and Talents) on July 23, 2026, at the Ammungan Hall, Provincial Capitol Compound, Bayombong, Nueva Vizcaya.

2. The activity aims to provide learners with disabilities meaningful opportunities to showcase their talents, skills, creativity, and abilities while promoting disability rights, Inclusive Education, and collaboration among schools, families, and stakeholders.

3. The celebration shall feature the following activities:
a. Inclusive Spelling Bee (Elementary Category)
b. Stories in Silence (Elementary Category)
c. Mr. & Ms. Possibility; and
d. Product Exhibition and Trade Fair.

Teacher-coaches, parents or legal guardians, School Heads, and Public Schools District Supervisors/Districts-in-Charge, and Education Program Supervisors shall likewise participate to support the learners, witness their talents and achievements, and strengthen school-family-community partnerships in promoting Inclusive Education.

5. School Heads shall ensure the identification of qualified participants, secure written parental or guardian consent, provide appropriate supervision, make the necessary arrangements to ensure continuity of learning during the learners' participation in the activity, and ensure compliance with the approved guidelines and mechanics.

6. Expenses for meals, snacks, activity supplies, printing of certificates, and other activity expenses shall be charged to the Program Support Fund–Special Needs Education (PSF–SNED). Transportation and other incidental expenses of participants, teacher-coaches, and school personnel shall be charged to the School Maintenance and Other Operating Expenses (MOOE) or other available local funds, subject to the usual accounting and auditing rules and regulations.

7. Participating schools are advised to refer to the guidelines, mechanics, criteria, and program of activities posted in the official group chat for reference and guidance.
