**CALL FOR SUBMISSION OF APPLICATIONS FOR THE LEARNING INITIATIVES
FOR NURTURING GUIDANCE ASSOCIATES AND COUNSELORS (LINGAP)
SCHOLARSHIP PROGRAM**

1. Pursuant to the Regional Memorandum issued by the Department of Education, Regional Office II, regarding the implementation of the LINGAP Scholarship Program, this Office announces the Call for Submission of Applications from qualified permanent teaching and non-teaching personnel of the Schools Division Office of Nueva Vizcaya.
2. The LINGAP Scholarship Program aims to provide financial assistance to qualified DepEd personnel pursuing graduate education, thereby strengthening professional competencies, promoting career development, and enhancing the quality of education through a highly competent and continuously developing workforce.
3. The program is open to permanent teaching and non-teaching personnel who are either:
 - a. Incoming graduate students; or
 - b. Currently enrolled in graduate studies.
4. Eligible applicants must be enrolled in, or intend to enroll in, any of the following graduate degree programs offered by a CHED-recognized Philippine Higher Education Institution (HEI):
 - a. Master's in Guidance and Counseling; or
 - b. Master's in Psychology.
5. Qualified applicants who are approved under the program shall be entitled to scholarship privileges in accordance with the provisions of the Joint Memorandum Circular and other applicable DepEd guidelines, including but not limited to:
 - a. Monthly stipend of Thirty Thousand Pesos (Php 30,000.00) per academic term;
 - b. Thesis allowance amounting to One Hundred Fifty Thousand Pesos (Php 150,000.00), subject to the prescribed conditions and requirements.
