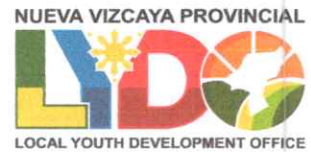

Warm youthful greetings!

The Provincial Government of Nueva Vizcaya, through the Provincial Local Youth Development Office in partnership with the Panlalawigang Pederasyon ng mga Sangguniang Kabataan, will be conducting the **Provincial Linggo ng Kabataan Celebration 2026** on **September 4-7, 2026**, in line with our continuing commitment to promote meaningful youth participation, leadership, and development.

One of the highlights of the celebration is the **Election of Young Officials**, wherein selected youth participants will serve as counterparts of local elective and appointive officials, pursuant to Republic Act No. 10742, otherwise known as the Sangguniang Kabataan Reform Act of 2015, as amended. This initiative aims to provide the youth with experiential learning opportunities in governance, public service, and civic engagement.

In addition, the Province will convene the **Nueva Vizcaya Youth Parliament (NVYP)**, which shall serve as a platform for policy dialogue, youth representation, and legislative simulation among participating learners.

In this regard, may the undersigned respectfully seek the support and assistance of your esteemed Office through the issuance of a Memorandum Order excusing participating learners and faculty members from their classes and/or regular school duties, subject to existing rules and regulations of the Department of Education.

Specifically, we respectfully request the following:

- The **Elected Division Federation of Supreme Elementary Learner Government (SELG) and Supreme Secondary Learner Government (SSLG) Officers, together with their Teacher-Advisers, for School Year 2026-2027;**
- **One (1) learner representative from each secondary school in the Province** shall be designated to participate in the **Election of Young Officials and the Nueva Vizcaya Youth Parliament (NVYP) on September 4-5, 2026**. The **SSLG President** shall preferably serve as the school's designated representative. In the event that the SSLG President is

unavailable, the **SSLG Vice President or another learner officially endorsed by the School Head** may be designated as the representative.

- Additional learner participants who will apply and be officially admitted to the Nueva Vizcaya Youth Parliament (NVYP), separate and distinct from the school-designated representatives, may likewise be excused from their classes on September 4-5, 2026, should there be any scheduled classes;
- The elected and appointed Young Officials shall be further **excused on September 7, 2026** to allow them to be deployed in their respective counterpart offices within the Provincial Government and other concerned agencies;
- Participating learners must be accompanied and supervised by a **designated chaperone** throughout the duration of the activity.

For proper coordination, the official list of admitted learner participants from DepEd schools shall be furnished to your Office on or before September 1, 2026.

This initiative is envisioned to form part of the learners' holistic learning experience, enhancing their socio-political awareness, leadership competencies, and appreciation of democratic processes and public service.

We believe that your support will greatly contribute to the success of this endeavor and further strengthen our shared commitment to nurturing empowered, informed, and engaged Kabataang Novo Vizcayano.

We look forward to your favorable consideration.

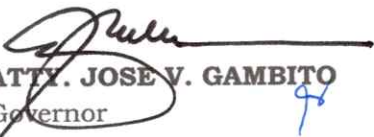
