1. Pursuant to DepEd Order No. 006, s. 2026, titled Policy Guidelines on Ensuring Safe and Motivating Learning Environment (ESMLE), this Office, through the School Governance and Operations Division-Learner Rights and Protection announces the conduct of **PAGHUBOG SA TAGAHUBOG: Capacity Building and Orientation on Ensuring Safe and Motivating Learning Environment on August 19–20, 2026** at the **SDO Conference Hall, Bayombong, Nueva Vizcaya**.

2. The activity aims to strengthen the capacity of *School Heads* and *Registered Guidance Counselors* in implementing the provisions of DepEd Order No. 006, s. 2026 or the Ensuring Safe and Motivating Learning Environment (ESMLE) Policy. Specifically, at the end of the activity, the participants are expected to:

- a. Explain the key provisions, policy framework, and implementation strategies of the ESMLE Policy, particularly its prevention and response mechanisms for Learner Rights and Protection (LRP) concerns;
- b. Strengthen the implementation of school-based prevention, reporting, referral, case management, and intervention mechanisms for Learner Rights and Protection concerns in accordance with existing DepEd policies and guidelines;
- c. Enhance the capacity of schools to implement appropriate school safety and security measures, as well as mental health and psychosocial support interventions that promote learner welfare and protection; and
- d. Develop or enhance school implementation plans and strategies that strengthen collaboration among schools, parents, local government units, partner agencies, and other stakeholders in ensuring a safe and motivating learning environment.
