1. The Schools Division of Nueva Vizcaya through the Curriculum Implementation Division (CID) announces the conduct of the Quarterly Engagement of District GMRC Coordinators **on September 24, 2026**, at 8:00 a.m. at Green Lake View Adventure, Purok 6, Masoc, Bayombong, Nueva Vizcaya.

TICs serving as GMRC District Coordinators who have classes in their respective schools shall prepare their lesson plans, conduct advance classes, or shift to alternative delivery mode in accordance with DepEd Order No. 9, s. 2005, " Instituting Measures to Increase Engaged Time-on-Task and ensuring Compliance Therewith."
6. Expenses on food and travel shall be charged to School MOOE or any available local funds, subject to the usual accounting and auditing procedures.
